WE OFFER TWO 24-HOUR HOTLINES, OPERATING 365 DAYS A YEAR THAT HAVE KNOWLEDGEABLE ADVOCATES PROVIDING CRISIS INTERVENTION, INFORMATION AND REFERRALS, HOSPITAL ACCOMPANIMENT, AND INTAKE FOR THE SHELTER AND COUNSELING PROGRAMS. THE HOSPITAL ACCOMPANIMENT PROGRAM DISPATCHES AN ADVOCATE TO THE HOSPITAL TO PROVIDE EMOTIONAL SUPPORT AND ADVOCACY. COUNSELING & ADVOCACY SERVICES PROVIDES COUNSELING TO ADULTS AND CHILD WITNESS/SURVIVORS OF DOMESTIC VIOLENCE AND SURVIVORS OF SEXUAL VIOLENCE IN INDIVIDUAL OR GROUP SESSIONS. SUPPORTIVE COUNSELING HELPS SURVIVORS OVERCOME TRAUMA AND UNDERSTAND THE VIOLENCE INFLICTED UPON THEM.

ALL SERVICES ARE PROVIDED IN A VERY SECURE AND SAFE ENVIRONMENT THAT ALLOWS FOR REFLECTION AND REPRIEVE FROM VIOLENCE.
